Is anonymous reporting allowed on this website?

What data is collected on this website?

All information you provide about yourself or others will be included in the report. Data we collect includes:

1. Your name,
2. Your email address,
3. Your phone number,
4. Your work location,
5. Your title,
6. The name of any other individuals involved in the reported misconduct,
7. The name of any other witnesses to the reported misconduct, and
8. Any other data you provide in the “Description” section of the report

What is the basis and purpose for collecting data on this website?

ACCO Brands USA processes data submitted on this website to comply with local laws, to further its legitimate interest in compliance with foreign laws as well as good corporate

governance, and based on your consent. Data collected on this website will only be processed to investigate and take action in response to reported misconduct.

Who may receive data submitted on this website?

Your data will only be shared with a restricted number of people as necessary to investigate and take action in response to your report.

Any data submitted on this website is collected by Convercent. Convercent is a data processor acting on behalf of ACCO Brands USA, the data controller, pursuant to a data processing agreement.

Data is then transferred to ACCO Brands USA management in the United States for further review and investigation. Depending on the content of the report, it will be handled by the Legal Department, Corporate Compliance Department, Internal Audit Department, or Human Resources Department. These business units are strictly separate from other business units. Their employees are specifically trained on and responsible for the confidentiality of reported data.

In the course of investigating or taking action in response to reports, ACCO Brands USA may share data with your employer and the following categories of third parties:

1. Outside counsel,
2. Outside accountants,
3. Self-regulatory agencies,
4. Governmental entities, or
5. Other third parties necessary for the completion of a comprehensive investigation of the reported misconduct

To what countries is data submitted on this website transferred?

Data submitted to this website is stored on Convercent's servers in the Ireland and Germany. Data is then transferred to ACCO Brands USA in the United States.

How is data submitted to this website protected?

To the extent permitted by law, your identity and any information you provide will be treated as strictly confidential throughout the investigation process, though affected employees are allowed to be informed of and given access to any accusations relating to them.

ACCO Brands USA and Convercent maintain adequate organizational and technical measures to protect data submitted on this website.

How long is data submitted on this website maintained?

Data will be deleted or anonymized within two months following the end of the investigation, as long as the data is not further required in order to defend or to proceed with any legal or administrative proceedings as well as any disciplinary or other official proceedings; in these cases, reported data will be stored for as long as required to proceed and finalise pending proceedings.
